APPLICATION FOR CONDITIONALLY EXEMPT SMALL QUANTITY GENERATOR (CESQG)

Please read first: State and federal laws exempt some commercial hazardous waste generators from strict waste management regulations, based on the amount of hazardous waste generated and stored.

In order to qualify for Conditionally Exempt Small Quantity Generator Status, your company must meet **<u>both</u>** of the following conditions:

- Produce less than 220 pounds or 28 gallons (100 kilograms) approximately ½ of a 55-gallon drum of hazardous waste in any given month; or no more than about 2.2 pounds or 1 kilogram, of acutely hazardous waste in any calendar month.
- 2. Never accumulate more than 2,200 pounds (1,000 kilograms) approximately 5 drums of hazardous waste on your property.

I further understand that if, in the future, I exceed the quantity limitations described above, I will become subject to additional regulation as a hazardous waste generator and will no longer be eligible to participate in this type of collection program.

I hereby certify the business listed is a generator of hazardous waste within the State of New York, County of Oswego and meets the above requirements. Due to the small volume of hazardous waste generated and/or stored qualifies me as a conditionally exempt small quantity generator (CESQG) status, per 6 NYCRR Part 372. I further certify that I have the authority to make these statements on behalf of my firm or business.
