## Fort Ontario Emergency Refugee Shelter

In January 1944, as World War II raged in Europe, President Roosevelt established the War Refugee Board, responsible for establishing temporary “havens” for refugees of the Nazi Holocaust in Europe. This was in response to the increasing and overwhelming evidence of Hitler’s atrocities and an ever-increasing problematic refugee situation in ally-occupied zones in Europe. Roosevelt believed the United States should share in the burden of caring for refugees despite isolationism and antisemitism at home. He chose to allow 1,000 refugees into the United States as his “guests” with no legal immigration status and a promise to return to their home country after the conclusion of the war. In June 1944, it was decided that Fort Ontario, a recently decommissioned military base in Oswego, N.Y. would be the site for the refugee shelter. President Roosevelt announced this decision on June 9, 1944, just three days after D-Day.

One thousand refugees were chosen and slightly less than that number made the journey to America. There were 18 countries represented, though most refugees were from Yugoslavia. Ninety Percent of the refugees were Jewish but other religions were represented, including Greek Orthodox, Catholic and Protestant. The refugees arrived in Oswego on August 5, 1944. Upon arrival to Fort Ontario, many of the refugees were surprised, scared, and angered to see a barbed-wire fence surrounding the compound. They felt they had left Europe for freedom and safety, but instead had been brought to another concentration camp. After explanations from military personnel and staff, the feelings of anxiety and apprehension faded for most of the refugees.

The Fort Ontario Emergency Refugee Shelter would ultimately be the **only** refugee shelter for victims of the Holocaust in the entire United States. The Safe Haven Holocaust Refugee Shelter Museum tells the story of the nearly 1,000 refugees who made the journey to America, from the unimaginable atrocities of the Holocaust to their journey throughout Europe and across the Atlantic, their time and life at the shelter, and the fight to allow the refugees to stay in the United States. This remarkable story is woven into the fabric of Oswego and is one of the area’s most unique and significant cultural assets.
